Conflict Dynamics offers Conflict Dynamics' accredited mediators the opportunity to add to their details currently available on the Conflict Dynamics website by including specific information about themselves. In this way, they will be more visible to potential parties for direct appointment as mediators.

These mediators will also be made available for appointment via Conflict Dynamics. Where parties contact Conflict Dynamics and request assistance in the appointment of a mediator, the Conflict Dynamics client advisor will provide a case management service from the selection and appointment of the mediator to the invoicing of the client and payment of the mediator. In this case a 10% management fee will be deducted from the mediator's fee to the client.

In addition, CD Direct mediators will be eligible for:

- FREE attendance at mediator meetings. Mediator Meetings are held a number of times each year, at least once in Johannesburg and at least once in Cape Town. Each meeting is two hours long, followed by an opportunity for networking over drinks and canapés.
- By arrangement, two FREE 30-minute pre-mediation coaching or post-mediation debrief sessions per annum with a Conflict Dynamics Director.

The cost of CD Direct is R1, 710.00 (inclusive of VAT) per annum.
